The Nebraska Minority Justice Committee, through the Nebraska Lawyers Foundation and the NSBA, established this scholarship program to help promote diversity within the legal profession. Baird Holm LLP is the lead supporter of this effort.

The program provides a scholarship for a Kaplan LSAT Prep course and covers the costs of registering for the LSAT exam. To be eligible for an LSAT Prep Scholarship, applicants must demonstrate economic need and be historically underrepresented in Nebraska's legal profession. The number of scholarships awarded annually is dependent on charitable contributions to the Nebraska Lawyers Foundation. To date, more than 50 LSAT Prep Scholarships have been awarded. On average, students experience an 8-point difference between their first practice exam and their final LSAT score.

"It's been exciting to be a part of such an important program, and to help provide assistance to students as they begin their journey into the field of law," said Richard Putnam, Managing Partner of Baird Holm. "We are thrilled that one of the past recipients became an attorney who now practices law at Baird Holm."
