The First Session of the 107th Nebraska Legislature convened January 6, 2021. Bill introduction concluded January 20, 2021. The deadline for priority bill listing was March 12, 2021. As of Tuesday, March 30, 2021, there are 38 days left in the session. The session concludes June 10, 2021.
